Fund Balance and Carryover Funds

Southeast Technical College shall maintain a cash reserve adequate to meet the cash flow requirements of STC. Annually during the budget process the administration reviews the current cash reserve and makes recommendations to the School Board as to the amount of cash reserve that should be maintained for the coming year.

The Vice President of Finance and Operations shall classify STC fund equity into the following components: Nonspendable, Restricted, Committed, Assigned, and Unassigned in accordance with generally acceptable accounting practices, subject to the approval of the Board with the annual June 30 Finance report.
